COMMUNITY/COURT COLLABORATION

<u>FATHERING COURT</u> - It is my honor and pleasure to have presided over the Fathering Court docket for this Circuit. Our Fathering Court docket is a diversion docket for fathers who are facing criminal charges for failure to pay child support. Participants in the Fathering Court are required to appear in Division 43 at least twice a month and must remain drug and alcohol free, must maintain full time employment or be vigorously seeking the same, must attend classes at the National Center For Fathering and must be paying toward their current and past due child support obligation.

FC provides services to afford fathers the opportunity to succeed with regard to all of the above and monitor them closely in their progress. We also facilitate re-establishing a relationship between the father and the child if the relationship is estranged due to failure to pay child support or other reasons. They do not graduate from the program unless they have made, and show the ability to continue to make, significant strides with regard to all of the above. To date we have generated over \$1,700,000 in child support payments that otherwise probably would not have been paid. Equally important, we have also taken a role in re-establishing countless father/child relationships.

This is a unique program which has garnered national attention and acclaim. Several jurisdictions, including St. Louis, Mo, Dade County in Florida, New Orleans, LA, Shreveport, LA, Baton Rouge, LA, Washington D.C. and several jurisdictions in Illinois and Texas have given us the opportunity to make presentations regarding the program with a view towards implementing the same in their jurisdictions. We have had feature articles regarding the program in the Kansas City Star, The Daily Record Legal Publication, the St. Louis Post Dispatch, and the Los Angeles Times. The Los Angles Times article was picked up and released in the New York Times, the Washington Post and elsewhere. This is a program that is extremely effective and a program of which I am very proud.

TRUANCY COURT - I am equally honored to have had the privilege of participating in the Jackson County Truancy Court. This is a program that has been instituted in several Kansas City area schools since its inception in 2001. It has had a tremendous effect on the children of Kansas City.

The Truancy Diversion Program is an incentive-based program designed to get at-risk

kids engaged and interested in school. The target child is a child that is struggling with school because of excessive absences. Oftentimes these children are also struggling because of behavioral issues and lack of parental support. The program attempts to get the family involved in school and encourage them to increase attendance and elevate their academic performance. This is truly a team effort among many participants. The parents, the children, the Juvenile Officer for Jackson County, the School administrators and teacher, the Judge and even the community as a whole take part in making this program work. It is imperative that the parents participate in the program.

The students must see that their parents are engaged and interested in order for them to take an active role. The judge's role is to look to and emphasize the good qualities of each individual child and, in doing so, attempt to get them enthusiastic and appreciative of the school setting.

The program has had remarkable success and is also one of which I am very proud.
